Dear Account Holder,

As previously communicated with you by letter and email on June 28 and July 14, and in accordance with Amendment No.2 referred to in such correspondence, there will be a one-time interest rate adjustment on September 1, 2023. The rate set for the period September 1, 2023 to December 31, 2023 is 4.75% per annum. Going forward, rates will continue to be set on January 1 and July 1 each year.
